**Re: California Open Education Resources Council**

Dear Mufaddal:

At its March 26 meeting, the Intersegmental Committee of Academic Senates (ICAS) ratified the appointments of nine faculty members to the California Open Education Resources Council (COERC) submitted by the Academic Senates of the University of California, the California State University, and the California Community Colleges. The Council members were identified and appointed by the Academic Senates through their own processes. The roster of members and a short biography of each are included below as an attachment to this memo.

This action fulfils the provision of Senate Bill 1052 requiring ICAS to appoint the nine-person Council comprised of three Senate members from each segment by April 1, 2013.

As ICAS mentioned to you on March 26, we hope to receive stronger assurances from the State about funding for the Council so that it may begin work on the central task outlined in SB 1052 – assembling a list of 50 lower division courses for which affordable, open source textbooks and materials can be identified or developed.

We also mentioned that ICAS believes it would be helpful to establish a liaison relationship between ICAS and COERC to facilitate communication, data collection, and the ability of the COERC members to link directly to faculty at the three segments. Assuming that you agree, ICAS will designate one member from each segment for this task.

We look forward to working with Senator Steinberg on this important project.

## *California State University*

**Diego Bonilla** is a professor of communication studies at California State University, Sacramento, where he serves as coordinator for the minor in Digital Communication and Information (which he developed). He earned his Ph.D. in Mass Communications at the S.I. Newhouse School of Public Communications at Syracuse University in 2003. His research interests include online learning, computer-mediated communication, new media engineering, digital storytelling, data tracking, immersive virtual environments, and critical thinking in electronic informational environments. Dr. Bonilla has served as Faculty Mentor and Coordinator of the Institute for Teaching and Learning, and has participated extensively in ICT Literacy assessment efforts. **Lawrence Hanley** is an associate professor of English at San Francisco State University (SFSU). Dr. Hanley joined the faculty at SFSU in 2008, and he currently serves as chair of the campus academic senate. He earned his Ph.D. in English at the University of Illinois at Urbana-Champaign. Dr. Hanley has designed, developed, and implemented a variety of courses incorporating open source platforms and materials.
