Members shared their impressions of today's visits.

Discussion: Members noted that several lawmakers were interested in student housing. In the future, ICAS might consider inviting a representative from the Legislative Analsyt's Office to a fall meeting instead of Legislative Day. Several visitors mentioned an interest in programming that relates to the governor's Cradle to Career statewide initiative. Conversations touched on the need to continue streamlining the process of transferring from the CCC system to either a CSU or UC campus including improving pathways like the California General Education Transfer Curriculum. Another theme is how the three segments can together navigate the challenging fiscal and political realities. Yet another theme is how ICAS can showcase its accomplishments to members of the Legislature, either as a component of Legislative Day or an annual report that would be freely accessible to the public at large.
